

# Statistics on the Health and Medical Services of Municipalities 2015


In 2015, more than 390,700 patients received care actions provided by municipal health and medical care. That was more than 8,000 patients more than 2014. . Of these patients, 84 per cent were 65 years or older.

### Municipal health and medical care

Municipal health and medical care is composed of care actions that the municipality provides the patients in their home or places they visit, such as special housing and daily activities. If the municipality has an agreement with the county council, they can also provide care actions in the patient's ordinary housing. The municipalities in Stockholm County (except Norrtälje) do not have that kind of agreement.

### 390,700 persons received care actions

In 2015 390,700 persons received at least one care action from municipal health and medical care. Of these, 23 per cent were women between 85 and 94 years old and there are clearly more women than men at these older ages. Figure A shows the number of men and women that received care actions in 2015 by age. The services can be given to anyone but, as Figure A shows, the absolute majority, 84 per cent, is 65 years or older. The percentage was the same in 2014.



## More than two out of three also received social services

More than 71 per cent of those who received municipal health and medical care also received social services meant for elderly or persons with impairments. Of these patients, 33 per cent lived in special housing, either pursuant to the Social Service Act, or through the Support and Service for Persons with Certain Functional Impairments Act. Table A shows the proportion of those who received care actions that also received social services or lived in special housing by county. In Halland County, 84 per cent of the patients received social services too. Kalmar County had the lowest percentage, 59. Kalmar also had a low percentage that lived in special housing while receiving care actions, around 21 per cent. Only Örebro County had a lower proportion, with 19 per cent.
