

# Statistics on the Health and Medical Services of Municipalities 2022


In 2022, almost 412,000 patients received care from Municipal health and medical services. Of these, over 338,600 persons were 65 years and older. For 75 percent of patients with municipal health care, there is information on patient-related interventions classified according to KVÅ.

#### Municipal health and medical care

Municipal health care refers to care and treatment, which through the municipality's responsibility, is provided in special forms of housing, day-today activities and home care in ordinary housing. Responsibility for home care in ordinary housing and in so-called aid-assessed security housing requires that the municipality has agreed with the regions to take over such responsibility. At the time of this publication, only the municipalities in Stockholm County (except for Norrtälje) do not have that responsibility.

## Elderly women are the largest group

Almost 412,000 patients received care from Municipal health and medical services in 2021. Of these, over 338,600 patients were 65 years and older. Women aged 65 years and older make up for half of the people with municipal health care. The second largest group is men aged 65 years and older, who make up for 32 percent. The gender distribution is uneven in the age group 65 years and older, 61 percent are women and 39 percent are men. While it is even in the age group younger than 65 years where 50 percent are women and 50 percent men.

#### Interventions (KVÅ)

A new regulation came into practice in 2019, which means that the National Register of Interventions in Municipal Health Care has been supplemented with information on patient-related interventions (KVÅ) performed by licensed healthcare professionals (excluding physicians) with the municipality as care provider. The information has been published in the National Board of Health and Welfare's (NBHW) statistical database, but not as official statistics because of missing data. At the time of this year's publication, thirteen municipalities have not reported interventions to the register. The NBHW has made the assessment that for 2022 the missing data is at such a level that publication of statistics is possible.

## Selection of interventions from KVÅ

The NBHW has together with representatives of the occupation's nurses, occupational therapists and physiotherapists selected a number of KVÅ codes. The selection covers all age groups in municipal healthcare and is updated annually. The selection for 2022 consists of 385 codes, of which 357 are grouped according to diagnostic and therapeutic interventions regarding body functions, activities and participation, environment and medication and other interventions, see table 1. This gives a good overview of the health care that patients receive.



### Reporting of interventions

In 2022, the municipalities reported interventions classified according to KVÅ for 310,800 patients, which corresponds to 75 percent of all persons with interventions in municipal health care. The reason why National Register of Interventions in Municipal Health Care are missing interventions for 25 percent of patients has mainly two reasons. One is that a significant proportion of patients receive municipal healthcare from private healthcare providers who are not obliged to provide information to the register. The second reason is missing data.

### **Diagnostic interventions**


Of patients with at least one reported intervention, 252,000 patients (81 percent) had received a diagnostic intervention. The most common diagnostic intervention was found under the section environment (PT) and was follow-up of assistive aid prescription and assessment of aid need. Then follows the intervention sampling UNS which is found under the section unspecified body functions (PI). Next comes mobility (PM), where a common intervention is assessment of changing body position. Very few patients have received diagnostic interventions in the sections communication (PL), domestic life (PP), community, social and civic life (PS), interpersonal interactions and relationships (PQ) and voice and speech functions (PC).



### Therapeutic interventions

Almost 279,000 patients (90 percent) have received a therapeutic intervention. The most frequent therapeutic intervention is found under the sections

environmental (QT) and medication (QU). The most common intervention under environment concerned testing and prescribing aids. Many patients also receive therapeutic interventions under the section functions of the skin and related structures (QH), where wound care is the most common intervention. Very few patients have received therapeutic interventions in the sections; communication (QL), voice and speech functions (QC) and domestic life (QP).
